State Use Council Chair

Message from the Chair:

As 2025 draws to a close, Georgia's State Use Council continues to advance its mission amid a dynamic economic and social landscape. While the state's expanding economy and job market signaled progress, these gains were tempered by persistent inflation and uncertainty surrounding future economic growth.

Established by the Georgia legislature more than three decades ago, the Georgia State Use Program was designed to create **meaningful employment opportunities for Georgians with disabilities** through Georgia Enterprises for Products and Services (GEPS). The program exemplifies a model in which everyone benefits; individuals with disabilities gain stable, rewarding employment; state agencies receive high-quality products and services at competitive prices; and participating non-profit agencies expand their capacity to serve communities across Georgia.

The State Use Council partners with the Georgia Department of Administrative Services (DOAS - the procurement agency for state purchasing), and with our Central Non-profit Agency (CNA), which is the Georgia Association of Training, Employment, and Supports (GATES) which the State Use Council designates to manage GEPS (the state entity which provides for the day-to-day operations of the State Use Program). Through collaboration among these organizations, the State Use Program continues to empower individuals with disabilities by creating meaningful, paid employment opportunities that supply Georgia's state agencies with essential goods and services. During Fiscal Year 2025, the Georgia State Use Program achieved sustained growth, reflected in an increase in total revenue.

The State Use Program is a true team effort, united by a single objective: expanding employment opportunities for Georgians with disabilities. At the core of the program are Community Rehabilitation Providers (CRPs) - nonprofit organizations that deliver the high-quality products and services central to the program's mission while offering vocational training and meaningful employment. Both the CRPs and the goods and services they provide are certified by the State Use Council to ensure compliance with program standards. To qualify, CRPs must maintain a workforce in which at least 50 to 75 percent of employees engaged in service contracts or product manufacturing are individuals with disabilities.

During Fiscal Year 2025, the Georgia State Use Program achieved **total revenue of \$7,705,402**, marking a **4% increase** from the previous year. This growth reflects the continued commitment of Georgians with disabilities who take pride in producing high-quality goods and services that keep our state running. **Product sales rose by 14%**, a testament to their skill, dedication, and perseverance. While **service revenue declined by 16%**, this change serves as both a reminder and an opportunity to strengthen partnerships, expand service offerings, and create even more pathways to meaningful employment for individuals with disabilities across Georgia.

The majority of service contracts within the State Use Program support custodial operations for State of Georgia agencies. Although COVID-19 infection rates have declined significantly from previous years, the demand for thorough cleaning and regular disinfection of state facilities remains essential. Across the broader industry, custodial staff shortages continue to pose challenges. However, GEPS and our Community Rehabilitation Providers (CRPs) have successfully met this demand by engaging a dedicated workforce of individuals with disabilities. These individuals, who often face higher barriers to employment, demonstrate both readiness and pride in stepping forward to provide critical custodial services that keep Georgia's government facilities safe, clean, and operational.

In Fiscal Year 2025, the Georgia State Use Program achieved a **29% increase in net assets**, bringing the total to **\$651,063**. This growth reflects our continued financial strength and the collective impact of our mission-driven partnerships. The Program created **59,672 hours of meaningful employment** for Georgians with disabilities - a reflection of our continued commitment to providing opportunities that make a difference in people's lives. While this represents a modest **13% decrease** in total hours from the previous year, we are deeply encouraged by the remarkable **83% increase in individuals employed, with 157 Georgians** now gaining valuable

skills, income, and independence through the program. Each of these individuals represents a story of perseverance, purpose, and pride. Although labor shortages continue to challenge the broader market, the dedication of our Community Rehabilitation Providers and the resilience of our workers inspire confidence that Fiscal Year 2026 will bring even greater opportunities for growth and impact across Georgia.

Looking ahead to **Fiscal Year 2026**, our outlook remains strong as we build on this momentum - expanding employment opportunities and empowering even more Georgians with disabilities to contribute their talents to our state's workforce. The State Use Program continues to advance its mission of expanding employment opportunities for Georgians with disabilities. Although Georgia's 3.1% **unemployment rate** remains below the national average of 4.3%, individuals with disabilities continue to experience significantly higher unemployment levels, underscoring the importance of this program and its ongoing work. This annual report highlights the **"Faces of State Use"** — the individuals whose dedication, skill, and perseverance embody the program's success. Their achievements and the recognition they have earned through the State Use Program illustrate how meaningful employment fosters both personal growth and community impact. As the need for job opportunities for Georgians with disabilities continues to rise, the State Use Program remains committed to addressing that need by creating pathways to stable, rewarding employment that benefits individuals, families, and communities throughout the state.

The State Use Program remains **focused on growth and innovation**, continually seeking new products and services that open doors to opportunity for Georgians with disabilities. In September, we successfully recertified hundreds of existing products for Fiscal Year 2026 and introduced several new offerings that reflect the evolving needs of our state partners. These efforts represent more than just expanded product lines; they signify progress toward a stronger, more inclusive workforce. Looking ahead, GEPS is committed to fostering creativity, collaboration, and expansion that will translate into even greater employment opportunities and lasting impact across Georgia.

We must continue working together to ensure that the State Use Program reaches even more individuals who benefit so deeply from its mission. The purpose that guided this program at its creation in 1993 remains just as vital today, empowering Georgians with disabilities through meaningful employment and inclusion in our state's workforce. This program serves the best interests of the **State of Georgia**, its employers, and the citizens whose lives it touches. I am confident that the State Use Program will continue fulfilling this essential purpose well into the future.

Moving forward will require the collective effort of all our partners - **DOAS, CRPs, GATES**, and the many advocates and community members dedicated to helping Georgians with disabilities succeed. Together, we can strengthen and expand this program, building a future where every individual has the opportunity to contribute, thrive, and overcome the challenges they face.

On behalf of the **Georgia State Use Council**, I invite you to join us in supporting our mission to create meaningful employment opportunities for Georgians with disabilities. As you review this report, you will meet the **"Faces of State Use"** — the individuals whose dedication, talent, and perseverance exemplify the impact of this

program. Their stories reflect the real difference the State Use Program is making every day in the lives of those it serves and in communities across our state.

We look forward to the continued growth and success of the State Use Program as it creates new opportunities and improves the lives of Georgians with disabilities across our state.

Spirit of State Use Award – Georgia State University

The Georgia State University nomination was inspired by their increased compliance with the State Use Law. The law does not mandate state agencies to buy any amount of products, but does mandate that when they do purchase those products that they already need, they purchase them from the State Use Program and GEPS. That, in turn, employs people like Erin Williams, one of this year's Working Wonders Award recipients, who has worked to provide those products, such as the Hand Soap, Hand Sanitizer, and Floor Maintenance Pads that New Ventures provides for the State Use Program.

In FY25, Georgia State University also significantly increased its purchases for Gloves from BDI and began buying Wiping Rags, which are provided by Easterseals of East Georgia. They also increased their purchases from GEPS for several other products from various GEPS CRPs across the state.

All of those purchases are very much appreciated and continue to provide those individuals with disabilities with the dignity of a paycheck. Georgia State University's commitment to continue purchasing those mandatory products from GEPS is the kind of cooperation that continues to provide even more employment opportunities for individuals with disabilities throughout the state of Georgia.





State Use Labor Hours of Disabled Employees FY 2024 & FY 2025 as of July 2025





Comparative State Use - Disabled Workers Used FY 2024 & FY 2025 as of July 2025

A Vision for Empowerment

The Georgia Legislature established the State Use Council in 1993 to offer quality services and products to be used by state and local government agencies. The statute requires state agencies and political subdivisions to purchase those products and services from Certified Rehabilitation Programs (CRPs) employing Georgians with disabilities. This, in turn, would improve the quality of life for Georgia's citizens with disabilities by providing employment opportunities from the production of those products and services.

The State Use Council designates a private nonprofit agency to administer daily operations on behalf of the Council. This program is Georgia Enterprises for Products and Services, and its nonprofit administering agency is the Georgia Association of Training, Employment, and Supports (GATES). The State Use Council ensures that services and products are priced at a fair market value and are of the highest quality. This is a unique partnership between the government and the private nonprofit sector. Georgia Enterprises for Products and Services operates on these guiding objectives:

- Dedication to encouraging and assisting individuals with disabilities to achieve maximum personal independence by engaging in useful and productive vocational activities.
- Working to facilitate and expand employment opportunities for people with disabilities through state and local programs.
- Striving to develop an environment for successful employment of people with disabilities through marketing research, public relations, and educational activities.
- Developing cooperative relationships with business, state, and local community leaders that promote programs that support the employment of Georgia's citizens with disabilities.
